### 1. Personal data

In the case of merely informative use of the website, that is, if you do not register to use the service, or transmit information to us, we do not collect any personal data, except the data that your browser submits to allow you to visit the website,

It refers to:

- IP address
- Date and time of the request
- Time zone difference to the Greenwich Mean Time (GMT)
- content of the requirement (concrete page)
- HTTP status code
- Transferred data volume
- Web site from which the requirement comes
- Browser
- Operating system and its surface
- Language and version of the browser software.

This data is collected exclusively for the purpose of troubleshooting, system analysis, statistics and the defense of cybercriminality. The collected data will be used anonymously only. Google Analytics is used. We create anonymous usage profiles.

## 2. Cookies

Cookies are used in various areas of our websites to manage your online visit. In such and similar cases, cookies can be used to indicate whether a time value stored in the cookie has already expired for the respective user, and the user is thus prompted for a new application. We assure that we only use cookies for the above purposes and do not use them for the creation of individual movement or other profiles.

## 3. Google Analytics

This website uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"). Google Analytics uses so-called "cookies", text files which are stored on your computer and which allow an analysis of the use of the website by you. The information generated by the cookie about your use of this website is generally transferred to a Google server in the USA and stored there. However, in the case of the activation of IP anonymisation on this website, your IP address will be abbreviated by Google within the Member States of the European Union or in other Contracting States of the Agreement on the European Economic Area. Only in exceptional cases will the full IP address be transferred to a Google server in the US and abbreviated there. On behalf of the operator of this website, Google will use this information to evaluate your use of the website, to compile reports on website activity, and to provide other services related to the use of the website and the Internet against the website operator. The IP address transmitted by your browser as part of Google Analytics will not be merged with other Google data. You can prevent the storage of cookies by means of a corresponding setting of your browser software; However, we point out that in this case you may not be able to fully utilize all the functions of this website.
